Sir,

With reference to your letter No OSD/GKU/2016/706 and OSD/GKU/2016/707 dated 10.10.2016, I am directed to inform you that Guru Kashi University, Talwandi Sabo, Dt. Bhatinda, Punjab has been established by an Act of State Legislature of Punjab as a Private University and is empowered to award degrees as specified under Section 22 of the UGC Act through its main campus at regular mode with the approval of Statutory Bodies/Councils, wherever its required. Guru Kashi University, Talwandi Sabo, Dt. Bhatinda, Punjab is not authorized to open study centre/off campus centre beyond the territorial jurisdiction of the state as per the judgment of Hon'ble Supreme Court of India in case of Prof. Yashpal Vs. State of Chhattisgarh. The University cannot open its centre(s) even within the state as per the provision of UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 without the approval of UGC. The UGC has not granted any approval to the University to open off campus/study centre.

As required under UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003, an Expert Committee of UGC alongwith AICTE Expert Committee visited University on 7-8th February, 2014 to ascertain fulfilment of criteria by the University in terms of programmes, faculty, infrastructural facilities, financial viability, etc.

The observations/suggestions given by the UGC and AICTE Expert Committee were communicated to the University to submit compliance report. The Compliance report submitted by the University was placed before a standing committee of the UGC Members. This Committee accepted the compliance submitted by the University. The recommendation of the UGC standing committee was accepted by the Commission in its 501st meeting (Item No 5.01) held on 13.06.2014.

Although approval of AICTE is not required for Universities to start course in the field of Engineering & Technology and Management, they have to maintain the norms and standards prescribed by the AICTE.
